Liability Release Form

Please read carefully before signing. This agreement will affect your legal rights.

I am aware that there are inherent dangers, hazards, and risks (collectively 'risks') associated with Equine Activities and injuries resulting from these risks are a common occurrence. I am aware that the risks associated with equine activities are unavoidable at times and may result in serious injury or death. I freely accept and fully assume all responsibility for all potential risks and possibilities of personal injury, death, property damage, animal injury or death, or loss resulting from my participation in equine activities in association with Dayberry Eventing LLC.

I understand that although the host (Nicole Dayberry) has taken steps to reduce the risk of equine activities it is not possible for the host to eliminate these risks. I accept these risks and agree to the terms of this waiver even if the host is found to be negligent or in breach of any duty of care or obligation to me in my and/or my horse's participation in equine activities with the host.

In addition to consideration given to the host for my participation in equine activities I and my heirs, next of kin, executors, administrators, and assignees (collectively my 'Legal Representatives') agree to release and forever discharge the host from all liability for any personal injury, death, property damage, animal injury or death, or loss resulting from my participation in the equine activities due to any cause including but not limited to: negligence, breach of any duty imposed by law, breach of contract, or mistake or error of judgment of the host.

I agree to be liable for and to hold harmless and indemnify the host from all actions, legal proceedings, claims, damage, cost demands, including court costs and costs on a solicitor and own client basis, and liabilities of any nature or kind arising from or in any connection with my participation in equine activities with the host.

I confirm that I have had sufficient time to read and understand this document in its entirety. I understand that this agreement represents the agreement between myself and the host and it is binding on myself and my legal representatives. I agree that should emergency medical treatment be required, I and/or my own accident/medical insurance company shall pay for all such incurred expenses.

Under Colorado Law, an equine professional is not liable for an injury to, or death of a participant in equine activities resulting from inherent risks of equine activities pursuant to sections 13-21-120, Colorado Revised Statute.

This agreement shall be effective and binding upon the parties hereto from the date indicated. **The parties hereto acknowledge having read and understood this agreement.**
